

JOB TITLE: Housing Project Attorney (1.0 FTE)

ORGANIZATION SUMMARY:

Volunteer Lawyers Network (VLN) provides free advice and legal representation to low-income individuals through volunteer attorneys, interpreters and other legal professionals. VLN is a private non-profit organization affiliated with the Hennepin County Bar Association. VLN's mission is to protect and promote the basic needs of people in poverty through the power of legal volunteers. VLN envisions a society where everyone has equal access to the legal services essential for stability and well-being. VLN's Housing Program provides on-site housing services at eviction calendars in Hennepin, Ramsey and Anoka counties. The Housing Program also assists tenants with repair cases, eviction expungement, and many other landlord/tenant issues.

JOB DESCRIPTION:

Come be part of a dynamic and collaborative team that mobilizes volunteers to provide legal services to low-income tenants going through housing court. The position is primarily responsible for managing VLN's housing court clinic work in Hennepin County and our repair litigation program. Ideal candidates should have a passion for justice, feel comfortable in a courtroom, enjoy teaching/mentoring and be able to engage effectively with a diverse set of people experiencing trauma.

Primary duties and responsibilities

- Ability to work in person 3 days per week in downtown Minneapolis. The remainder of this position can be done remotely.
- Oversee the implementation and day-to-day operation of VLN's eviction defense volunteer program in Hennepin County, including recruiting, training and supporting volunteers and overseeing/staffing eviction calendar shifts.
- Screen and place repair/habitability cases with volunteer attorneys and provide appropriate follow-up for cases not placed with volunteers.
- Represent income-qualified clients in eviction and repair/habitability cases as needed to develop and maintain legal skills, cover volunteer shifts and train new attorneys.
- Create and update substantive and procedural resources for volunteers, including CLEs, online resources, and materials provided to volunteers.
- Participate in and contribute to VLN's housing team, including supporting an office-wide culture of engagement, teamwork, transparency, and accountability.
- Other duties as assigned or needed.

Qualifications:

- Licensed to practice law in Minnesota
- Demonstrated commitment to access to justice and serving low-income communities
- Litigation, poverty law, or housing law experience
- Ability to work independently, multi-task and take initiative
- Willingness to take risks and be flexible
- Experience working with people from communities of color and other diverse backgrounds
- Knowledge of local community resources and other social services a plus
- Experience managing volunteers a plus
- Proficiency in a second language a plus
